The Ministry of Local Government received a complaint from a whistleblower 1.0 INTRODUCTION about irregularity in the recruitment process for the Parish Chiefs and Principal Ward Agents and unfilled critical positions in Kagadi District Local Government. In the complaint, the Whistleblower alleged that Seventeen (17) Parish Chiefs out of those recruited did not have the required qualifications.

It was further alleged that some critical positions remained unfilled since the creation of the district six years ago simply because they are 'ring-fenced for the District Leadership acquaintances. The positions are: District Engineer, District Natural Resource Officer, District Health Officer, Superintendent, District Planner, Principal Nursing Officer, Commercial Officer and Principal Human Resource Officer-District Service Commission. These positions have remained unfilled since the creation of the district due to 'ring-fencing'.

Upon receipt of the complaint, a team headed by the Minister of State for Local Government was constituted to investigate the allegation. This report details the investigation carried out by the team. It has a background, terms of reference, methodology, findings and recommendations.

3.0 TERMS OF REFERENCE FOR THE INVESTIGATIONS

The team was tasked to investigate allegations relating to:

a) Appointment of some candidates to the position of Parish Chief and Principal Ward Agent based on forged academic papers;

b) Failure by the District to fill the critical positions since the creation of the District having ring-fenced them for their own acquaintances; and

c) Irregular appointment of 68 staff in different sectors.

4.0 METHODOLOGY

The team employed the following methodology to carry out the investigation:

- a) Review of the relevant documents, including the application forms for the recruited Parish Chiefs, minutes of the District Service Commission, Investigation Report on Irregular Recruitment of Employees by Ministry of Public Service and other correspondences;
- b) Meeting the District technical and political leadership; and
- c) Interface with Officers in acting positions.

5.0 FINDINGS AS PER THE TERMS OF REFERENCE

5.1 The allegation that some candidates appointed to the position of Parish Chief and Principal Town Agent presented forged academic papers

The District Service Commission in its ... sitting on appointed 105 Parish Chiefs and Principal Town Agents.

The job requirements for the post of Parish Chief was a Diploma in Public Administration and Management, Social Work and Social Administration, Development studies or Business Administration from a recognized Institution.

On the allegations that Seventeen (17) Parish Chiefs out of 105 recruited did not have the required qualifications, it was established nine (9) have authentic academic documents, five (5) have forged documents, two (2) are from Non Recognised Institutions by the National Council For Higher Education and one (1) was a duplication as indicated in table 1.
